

## Music Creativity Camp

### Arrival and Dismissal

I understand that I have been directed to drop off and pick up my child inside Music Creativity Camp. It is not safe to ask my child to meet me outside and I have instructed my child in this matter. I understand that delivering and picking up my child to/from class late is very stressful to my child and other children in the class. I will try to be punctual in arriving and leaving for my child's class. I will make every attempt to notify Music Creativity Camp LLC prior to arriving for pick up or drop off late.

### Removal from Classes and Camps

I understand that Red Square Audio, LLC reserves the right to remove any child from class for disciplinary reasons and removed children are not afforded a refund or credit for missed time.

Removal from Camps Policy: If a child is removed from camp for disciplinary reasons a full refund will be issued for any remaining weeks/days that were paid for to attend camp.

Camp Cancellation Policy: Red Square Audio, LLC must be notified two weeks prior to the start of the week you are cancelling. Red Square Audio, LLC will refund the week's payment, less \$25 administration fee. Cancellations within 2 weeks of the camp starting will not be given a refund or make-up.

Respect all instruments, equipment and property. Treat them with care.

Turn off all cell phones, iPhones, iPods, and any other electronic devices during workshops and classes unless given special permission for use by the instructor. Always respect each other's differences in race, ethnicity, ability, gender identity, size, sexuality, religion, politics, and economic status. No foul or offensive language.

No violence of any kind. Bullying will not be tolerated. No drug/alcohol consumption or possession on Music Creativity Camp premises. No smoking on Music Creativity Camp premises.

I have read these guidelines. I understand that any violation of these guidelines can lead to suspension or expulsion from any of the programs at Music Creativity Camp without a refund in tuition.

### Payment Information

I understand that the full payment is due on or before the 1st day of the camp session. Red Square Audio, LLC offers e-payment, check or cash payment options that are free of charge. I understand that if any check returned to Red Square Audio, LLC for insufficient funds will incur a \$35 fee.

I understand that there will be a convenience fee \$10 added when using a Credit Card option. The Red Square Audio, LLC office will only take one time payments. A payment receipt will be emailed to you.

### Release of Liability

LIABILITY WAIVER AND INDEMNITY AGREEMENT: As conditions of the participation of the student described previous ("my child") in any of the programs conducted by Red Square Audio, LLC, including but not limited to events and programs, whether conducted on or off the premises of Music Creativity Camp, I agree to the following:

### Consent to Medical Treatment and Release of Liability

In consideration of being allowed to participate in the camp, related events, and activities, I hereby Release, Waive, Discharge, and Covenant Not to Sue Red Square Audio, LLC, their officers, servants, agents, employees, this camp, and its employees, and directors (hereinafter referred to as Release) from any and all liability, claims, demands, or course of action whatsoever arising out of or relating to any loss, damage, or injury, including death, that may be sustained by me/my child, or to any property belonging to me/my child,

whether caused by the negligence of the release, or otherwise, while participating in this camp, or while in, on or upon the premises where the camp is being conducted.

To the best of my knowledge, my child is in good physical condition and I am not aware of any physical infirmity which would place my child at risk to participate in any way with camp activities. I am fully aware of the risks and hazards connected with Music Creativity Camp. I VOLUNTARILY ASSUME FULL RESPONSIBILITY OF ANY RISK OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY INCLUDING DEATH, that may be sustained by my child, or any loss or damage to property owned by me/my child, as a result of being engaged in Camp activities, whether cause by the negligence of the release or otherwise. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASE from any loss, liability, damage or cost, including court costs and attorney's fees, that may accrue related to me/my child's participation in this camp.

During the period of camp, I hereby give permission for the staff of Music Creativity Camp to administer appropriate medical attention to my child in the event of an accident, illness or injury. I will be responsible for any and all costs of medical coverage and treatment provided not covered by insurance.

It is my express intent that this WAIVER OF LIABILITY and HOLD HARMLESS AGREEMENT shall bind the members of my family and spouse, if I am alive, and my heirs, assigns personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the above named RELEASEE, I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Wisconsin. In signing this release, I acknowledge and represent that I have read and understand it and sign it voluntarily; I am at least 18 years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by the same.

I have read this waiver of liability and sign it freely and voluntarily without inducement.

#### Medical Emergency

AUTHORIZATION OF MEDICAL CARE: In the case of illness or injury, if I cannot be reached, I authorize and desire medical care for my child at the discretion of the attending physician. I accept responsibility for all associated expenses.

AUTHORIZATION OF LIKENESS RIGHTS: At any given time Red Square Audio, LLC may take photographs, audio or video recordings of classes and performances.
